## WHITE COURSE APARTMENT LEASE AGREEMENT RELEASE REQUEST

The White Course Apartment Lease Agreement is a legally-binding contract. Once the Lease Agreement has been accepted, the Tenant is obligated to reside on campus and is financially responsible for rent charges for the lease period. A Tenant with an extreme circumstance may be considered for a Lease Agreement Release on a case-bycase basis. Per the terms of the Lease Agreement, if a Lease Agreement Release is granted, the tenant is responsible for liquidated damages for Tenant's early termination of the Lease Agreement (including failure to take possession). Landlord shall be entitled to retention of the Deposit in addition to any amounts it may recover as damages for unpaid rent pursuant to the terms of this lease

**Determination**: The submitted form will be reviewed by a committee. The student will be informed of the final determination by email within 1-2 weeks after the initial submission of paperwork.

**Deadlines**: Lease Agreement Release Requests must be received by the following deadline dates:
